ARTICLES OF INCORPORATION

I, the undersigned, being a natural person of twenty-one years or more, do make and acknowledge these Articles of Incorporation for the purpose of forming a corporation under the Non-Profit Corporation Act of the State of North Carolina and, to that end, do hereby set forth:

ARTICLE I

The name of the Corporation is KNIGHTDALE SOCCER LEAGUE.

ARTICLE II

The purpose for which the corporation is organized are:

- (A) To educate children in the Knightdale area on the sport of soccer, and to teach them the proper way to participate in the sport.
- (B) To promote sportsmanship and teamwork in the children who participate in this sport.
- (C) To aid and encourage children in these age groups to becoming better adults through learning in community sports programs.

ARTICLE III

The corporation is to have members. Members of the corporation shall consist of person satisfying the requirements for membership in the corporation. Members may be divided into two or more classes having such voting and other privileges as are from time to time set forth in the Bylaws.

ARTICLE IV

The method of selecting directors shall be as set forth in the Bylaws of the corporation.

ARTICLE V

The address of the initial registered office of the corporation is 205 Wellington Dr. Knightdale, Wake County, North Carolina 27545, and the name of the initial registered agent of the corporation at such address is ANDY M. BAREFOOT (President)

ARTICLE VI

The number of persons constituting the initial Board of Directors of the corporation shall be 4; and the names and addresses of the persons who are to serve as the initial Board of Directors are as follows:

ARTICLE IX

In the event of termination, dissolution, or winding up of the corporation in any manner or for any reason whatsoever all of the assets of the corporation shall be disposed of in accordance with provisions of a Plan of Dissolution, which shall not violate the provisions of ARTICLE VIII above, to be adopted prior to such termination, dissolution, or winding up of the corporation.
