

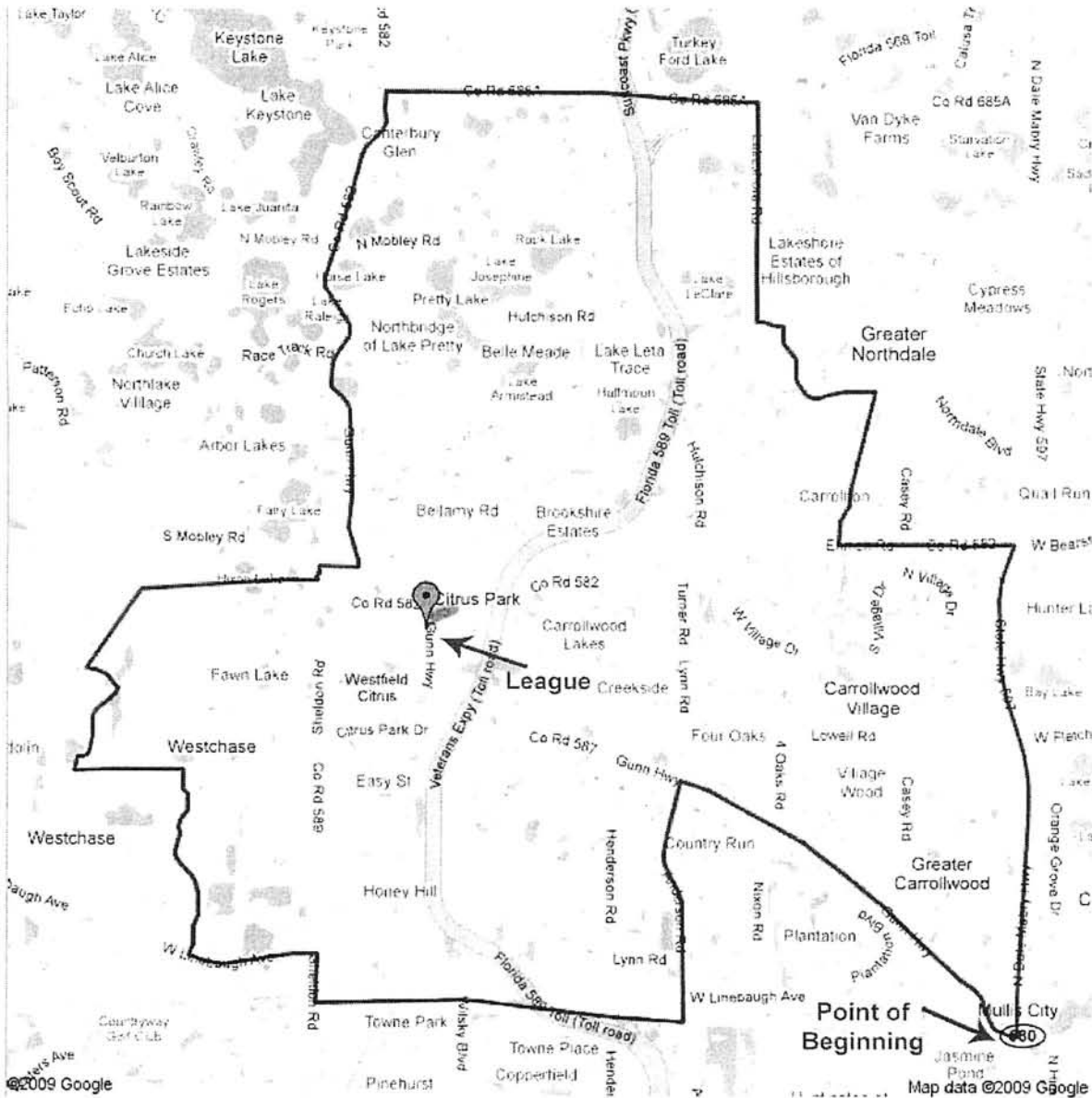

LEAGUE BOUNDARY WRITTEN DESCRIPTION

REV 12-9-2009

- **POINT OF BEGINNING:** Centerpoint of SR 597 (Dale Mabry Highway) at SR 580 (Busch Blvd.).
- North on centerline of SR 597 (Dale Mabry Highway) to Ehrlich Road.
- West on centerline of Ehrlich Road to Bushy Creek Canal.
- North on centerline of Bushy Creek Canal to Northdale Boulevard.
- NW on centerline of Northdale Boulevard to Newkirk Drive.
- West on centerline of Newkirk Drive to Lakeshore Road.
- North on centerline of Lakeshore Road to Van Dyke Road.
- West on centerline of Van Dyke Road to Gunn Highway.
- South on centerline of Gunn Highway to Beaty Grove Drive.
- West on Beaty Grove Drive to end of street.
All residences on Beaty Grove Drive are included within the Citrus Park boundary.
- South to the North boundary of Sickles High School.
- West along the North Boundary of Sickles H.S. to the NW property boundary of Sickles H.S.
- Follow a straight line from the Northwest property boundary of Sickles High School to the Southeast corner of Ed Radice Park (at soccer fields).
- Follow a straight line from the SE corner of Ed Radice Park (at soccer fields) to the centerpoint of the intersection of Ed Radice Drive and Dale Stitik Road.
- From the centerpoint of the intersection of Ed Radice Drive and Dale Stitik Road, South on Dale Stitik Road to Citrus Park Drive. All residences on Dale Stitik Road (North of Citrus Park Drive) are excluded from the Citrus Park boundary.
- East on centerline of Citrus Park Drive to Montague Street.
- South on centerline of Montague Street to Linebaugh Avenue.
- West on centerline of Linebaugh Avenue to Sheldon Road.
- South on centerline of Sheldon Road approximately 1,400 feet to the CSX Railroad Tracks.
- West on the centerline of CSX Railroad Tracks to Anderson Road.
- North on centerline of Anderson Road to Gunn Highway.
- SE on centerline of Gunn Highway to **Point of Beginning**.


