AUTHORITY

In accordance with Little League policy, the District governs Interleague Play.

AGREEMENT

This Agreement outlines the local League's agreement to participate in Interleague Play and must be executed by each local League that desires participation in Interleague Play. Your league may not participate in Interleague Play without this Agreement.

RULES

Each participating League agrees to comply with the Rules, Regulations, and Policies of Little League Baseball & Softball, as well as all District 6 Interleague Rules, as amended from time to time. The District 6 Interleague Rules are hereby incorporated into this Agreement as an Addendum. This Interleague Agreement and the District 6 Interleague Rules are intended to be in compliance with all rules, regulations, and policies of Little League Baseball, Inc. If any discrepancies are found, the Rules and Regulations of Little League Baseball shall govern. Current District 6 Interleague Rules are available on the District's website (www.FLD6.org).

LEAGUE REPRESENTATIVES

Each league will assign two (2) League Representatives, one (1) for Baseball and one (1) for Softball, to be the single point of contact for District Interleague Play. The League Representatives must have the authority to act on behalf of his/her league in all matters regarding Interleague Play.

DISTRICT NEWSLETTER REGISTRATION

To facilitate communication out to the leagues, each league must have all League Managers, Coaches, League Board Members, and League Representatives register for the District eNewsletter on the District website (FLD6.org). Major announcements, meeting dates and other important information is disseminated via this email-newsletter system.

DISTRICT REPRESENTATIVES

The District Interleague Representatives are listed on the District website. If problems arise during Interleague play, please notify your ADA & Director of Baseball or Softball, as well as the ADA for your individual division of play.

DISTRICT INTERLEAGUE COMMITTEE

District 6 will provide the following committees to resolve Interleague issues & disputes.

BASEBALL: District Administrator, ADA & Director of Baseball, ADA of the Division.

SOFTBALL: District Administrator, ADA & Director of Softball, ADA of the Division.

The District Umpire Consultant in Chief (UCC) and a District Senior Umpire Consultant will be consulted and included in the decision process if the matter relates to Little League Playing Rules or District Interleague Play Rules.

DISPUTE RESOLUTION

The District Administrator reserves the right to impose sanctions and/or disciplinary action as a result of any Rule violations or altercations according to the LLB Rules and/or District 6 Interleague Play Rules and may be in addition to any League-imposed sanctions or disciplinary action.

REQUIRED LITTLE LEAGUE FORMS

PRIOR to a team being scheduled to participate in any Interleague Play games, the President of the league MUST submit a "[Little League Application for Interleague Play](#)" form to the District Administrator for approval and submission to Southern Region Headquarters for LLB approval. Approval must be granted prior to the team participating in any Interleague Play games. YOUR LITTLE LEAGUE INTERLEAGUE PLAY FORMS WILL NOT BE SIGNED BY THE DISTRICT WITHOUT THIS AGREEMENT.

REQUIRED DISTRICT 6 FORMS

In addition, each League President MUST submit a [District 6 Interleague Play Request Form](#) for each Division for which Interleague Play is requested. Managers, coaches, and team names, as well as phone and email information is required to be submitted to the District.

INFORMATION TO TEAMS & UMPIRES

Each League President shall provide:

- an "Official Regulations and Playing Rules" book to each Team Manager and Umpire.
- a copy of this Interleague Agreement to each Team Manager and Umpire.
- a copy of the Interleague Rules, as amended, to each Team Manager and Umpire.
- a copy of the applicable Interleague Schedule to each Team Manager.
