To that end I will complete the required **CONSENTS FOR DISCLOSURE OF CRIMINAL RECORD INFORMATION** forms and deliver them to the RCMP within five (5) days of receipt, and then do anything necessary to assure the Association that I am a desirable member and volunteer. I understand that, if appointed, my position is conditional upon the Association receiving no inappropriate information on my background. I hereby release and agree to hold harmless from liability the North Vancouver Central Baseball Association, Little League Canada, Little League Baseball Incorporated, and the officers, employees and volunteers thereof, or any other person or organization that may provide such information. I also understand that, regardless of previous appointments, the Association is not obligated to appoint me to a volunteer position. If appointed, I understand that, prior to the expiration of my term, I am subject to suspension by the President and removal by the Board of Directors for violation of Association or Little League policies or principles.

I will act in the best interest of the league's objectives at all times, particularly when that involves the physical and emotional safety and security of children.
